The purpose of the hearing will be to receive public comments on the proposal to sell general obligation limited tax bonds of the District, in one or more series, in the amount of not to exceed \$60,000,000 for the purpose of financing capital improvement programs of the District for the payment of land condemned or purchased for parks, for the building, maintaining, improving and protecting of the same and the existing facilities of the District, including the payment of outstanding bond anticipation notes of the District and for the payment of expenses incident in the issuance of the bonds, all as enumerated in Section 20 of the Chicago Park District Act.
