Supplementary Information Regarding Aramark's Proposed MWBE Participation

As a managed services provider, Aramark understands the importance of developing strong business relationships. Aramark's ability to identify, attract, develop, and support the right relationships with suppliers, vendors and service providers is key to our mutual growth. Our client base and the customers we serve represent the full range of diverse populations, and we believe that our local suppliers also should represent the diversity of the communities in which we live and work. We understand that each client is different and that flexibility is key. That's why we take a customized approach to supplier diversity in each unique area we serve.

We have a centralized, enterprise-wide program focused on identifying appropriate diverse suppliers and ensuring compliance with our clients' expectations. We work with our customers to develop a plan that makes the best use of regional and local resources, including diverse suppliers where appropriate.

Given the unique nature of the services sought by the RFP and that the submitter can subcontract out no more than 75% of the services, Aramark's potential use of subcontractors in its MWBE Participation Plan is limited. Aramark's proposal includes subcontracts with several key subcontractors, including V3 Construction Group, Ltd. and Integrated Lakes Management, Inc. (d/b/a ILM-Trusted Care of Land and Water), and, as part of Aramark's MWBE Participation Plan, includes two MBE subcontractors (Ward Environmental Services, Inc. and A&B Sanchez Landscaping, Inc.) and one WBE subcontractor (City Escape Garden & Design Center, LLC). Using these MWBE and non-MWBE subcontractors, Aramark approaches the 75% subcontractor limit set forth in the RFP. Accordingly, Aramark proposes to use a direct supplier, Anzy Supply, Inc., and indirect supplier Cristina Foods, Inc., to achieve the MWBE participation level sought by the RFP. Cristina Foods provides food supply/distribution services for Aramark at several of our other Chicago accounts, including the University of Chicago and Chicago Public Schools. Cristina Foods' contract is not with Aramark Management Services Limited Partnership but with another Aramark entity that is also – like Aramark Management Services Limited Partnership – owned by Aramark Services, Inc. Ultimately, both the Aramark entity servicing the Chicago Park District and the Aramark entity serving at Aramark's other Chicago area accounts, are part of the same company.

As also noted in the Schedules, depending on the services awarded pursuant to the RFP, Aramark may need to make adjustments to the MWBE participation plan detailed here and in Aramark's proposal.
