We are pleased to inform you that Clarity Partners, LLC has been re-certified as a Minority Business Enterprise ("MBE") by the City of Chicago ("City"). - File your recertification within the required time period.

Please be reminded of your contractual obligation to cooperate with the City with respect to any reviews, audits or investigation of its contracts and affirmative action programs.
