AUTHORIZATION TO ENTER INTO A CONTRACT WITH FRIEDLER CONSTRUCTION COMPANY FOR THE DEVELOPMENT OF PARK #564 SPECIFICATION P-11004-082-R

To the Honorable Board of Commissioners of the Chicago Park District

I. Recommendation

It is recommended that the General Superintendent and CEO or his designee enter into a contract with Friedler Constriction Company for the development of Park #564. The contractor was selected pursuant to a Request for Proposal ("RFP") to the Pre-Qualified pool of General Contractors. No work may commence and no payment shall be made to vendor prior to the execution of a written agreement.

Scope of Services: Within the 278 acre park, roughly 40 acres on the southern and eastern sections will be developed into a

bike park. This off-road, dirt base bike park is designed for all skill levels. The bicycle improvements were modeled after the highly successful Valmont Bike Park in Boulder, Colorado. The development will include single track mountain biking trails in addition to many other technical bike features. Additional site

This project was issued as a Request for Proposals ("RFP") on March 21, 2016 to the Pre-Qualified Pool of General Contractors. Department of Purchasing ("Purchasing") received a request to extend the proposal due date which was granted. On April 15, 2016, the proposal due date was extended 4 calendar days to April 22, 2016.

Four (4) proposals were received on the due date and all proposals were found by Purchasing to be compliant and responsive.

The Evaluation Committee ("EC") was comprised of three (3) voting members, all CPD staff. The EC began their evaluation of the proposals on April 26, 2016. On April 29, 2016 Friedler Construction, the submitter, was invited in for a meeting to discuss their proposal.

V. Explanation

This bike park development along with the ongoing habitat restoration will activate this park. It will also become a catalyst to attract visitors to this location as well as other Calumet natural areas within the City. These improvements will allow its visitors to experience nature within the Chicago limits offering both active and passive activities.

VI. General Conditions

- 1. *Conflicts*: No agreement authorized herein shall be legally binding on the Chicago Park District if entered into in violation of the provisions of the Public Officer Prohibited Activities Act, 50 ILCS 105/0.01 *et seq*.
- 2. *Ethics*: The Chicago Park District's Ethics Code, Chapter III of the Code of the Chicago Park District, shall be incorporated into and made part of all agreements authorized herein.
- 3. Contingent Liability: Any agreement lawfully entered into for a period of more than one year shall be executory only for the amounts for which the Park District may become liable in succeeding fiscal years pursuant to Section 17(i) of the Chicago Park District Act, 70 ILCS 1505/17(i). All agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year budget.
- 4. Economic Disclosure Statement ("EDS"): Contractors have submitted a full and complete EDS prior to execution of the contract.
